2. **Period.** 02 – 06 Feb 26
3. **Ranges Active.** 02 – 06 Feb 26
4. **Live Firing.**
 - (1) 02 – 06 Feb 26
5. **Dry Training.** Nil
6. **Danger Areas.**
 - a. **Land:** Brown Hill, Figure of Eight, Lovers Bower, Netherlaw, Netherlaw Wood, Abby Burn Foot, Masions Walk, Sheep Wash, Craigraploch, Chapel Hill, Corrahill, Planting Hill, Mulloch, Big Raeberry
 - b. **Sea.**
 - (1) **Coast.** Howwell Bay to Abby Burn Foot
 - (2) **Sea.** 12.5km out to sea
 - c. **Air.** Upper Height Limits:
 - (1) EGD405 – 15,000Ft.
7. **Barriers.** Barriers are to be locked in accordance with Normal Operating Procedures contained in LSS Assignment Instructions. Copies are available in Range Control and all vehicles. Additional Barriers are detailed below:

8. **Livestock.** The following field numbers are to be cleared of all Livestock Monday to Friday during firing:

East: 88, 102-113 & 120-122

The following field numbers are within the ricochet area and Livestock can be left in these fields however, it is at the farmers own risk and access during Live Firing is still prohibited:

Centre: Field 21

East: Fields 32 – 34, 66 – 80, 86, 87, 90, 93 – 119, 126 & 127

9. **Range Control.** Range Control may be unmanned during non-firing periods. Contact telephone numbers are 0141 224 +ext:

10. **Farmed Areas.** Farmers are to contact Range Control on the above numbers for advice on which areas are safe for grazing/working.

11. **Warning.** Do not touch or remove any object suspected to be military debris, ammunition, or suspected unexploded ordnance - mark the spot and report it immediately to Range Control on 0141 224 8520, or to the Guardroom on 0141 224 8502/07.

Notes:

1. **Access to range areas for any reason during firing times must be arranged through UK DTE Core Staff – DTSM/TSO.** Tenant farmers must ensure that their employees comply with this instruction. They must also ensure that they and their employees are clear of the range area by **0800 hrs** on firing days and are to inform Range Control when they are clear.
2. All grazing, cropping and other farming activity is carried out at the tenant farmer's risk.
3. Ploughing, cropping, fencing, ditching or any other such works will only be permitted after permission has been obtained from Defence Infrastructure Organisation (DIO) Lands and the TSO.
4. Tenant farmers are to ensure that range fences/gates are **Not** removed by their employees or by contractors.
5. Any damage caused to fences, dykes, etc by Military activities is to be reported to the Landmarc Helpdesk on 0800 0223334.
6. KTC Public Access footpaths are open when ranges are not active. Other access opportunities may be available by arrangement. Contact KTC on the above numbers for information or advice. The footpaths may be open during dry training exercises, but users must be aware of vehicles and troops on the ranges, and blank firing taking place.
7. In the event of this firing programme being changed, those affected will be notified where possible.
